- Well-Child Visits in 1st 30 Months First 15 Months
- Well-Child Visits in 1st 30 Months 15-30 Months
- Child and Adolescent Well-Care Visits 1 or More Visits

The Department has also removed Well Visits and Health Neighborhood measures as KPIs for incentive payment.

- Remove retired Health Neighborhood measure from KPI dashboards
- Move Well Visits measure from KPI dashboards to Other Program Measures dashboard




